The colossal number of children abducted by this heinous industry is done by fabricated reports, out of malice and for profiteering - and the numbers are staggering.

What this does to children and parents is inhumane

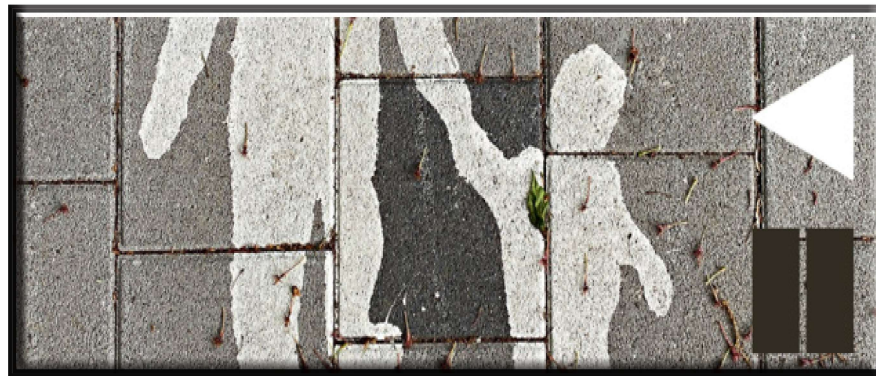
Analysis

In the 2022 financial year alone - the number of UNSUBSTANTIATED removals was 15601 - lets pause on that for a moment: that is 15 full high schools of children removed from their happy homes - on unverified gossip 'assumptions' - imagine that- in one year - in this country: with 30,000 more substantiated, by nebulous measures.

This means, TENS OF THOUSANDS of children are stolen EVERY YEAR from their safe, happy, loving homes UNSUBSTANTIATED, on groundless claims of assumptions by 'hearsay' of nonsense, gossip reports yet, kept in the system regardless, and not returned.

Horrific treatment done by 'child protective services' to children and their parents :

Children are snatched by ambush and stolen from their parents on nonsense allegations which are not a risk of harm, by 'assumptions' of a department 'caseworker' (junior clerk), following a sales lead of a gossip report 'notification' - which anybody can make without that credibility tested.' - children are stolen on a 'rumour' then not returned when unsubstantiated - this is abhorrent; these caseworkers are overly empowered by their system masters yet are (complicit) pawns in their beast industry, stealing astronomical numbers of children from competent parents every year, by gossip reports which are unsubstantiated, based on lies and fabricated reports of a 'social worker' or 'caseworker' on the payroll of the heinous child stealing departments that calls itself 'Child Protection'; These 'department are running a business strategy by a 'nonsensical'



overstep of the day to day parenting role - a government 'involving themselves' without necessity on gossip report makers, caseworkers creating controversies on nonsense - to steal children, persecute parents and destroy families, for profit and control - in what is deemed in global reports, as the intentional destruction of pro-family...

-all by the masquerade of 'child protective services' - an industry proven and evidenced, to operate on lies, deception, fabrication, obfuscation and tyranny - and unjustly profiteering by stealing and keeping children from their families - without necessity.

They are not about care. A business is about strategy and money; and, by the evidenced data; the astronomical number of children removed each year makes for a busy, profitable businesses...

-at the expense of the family unit: A caseworker clerks keep a job, their managers keep a job, a judiciary system keep a job, public servants and 'Ministers of their acts' keep a job; in a major conflict of interest...

At the expense of the immense suffering of children and families by terrorising them, abducting innocent children by ambush and robbing parents of their children who are already happy, safe and loved at home with their loving caring competent parents.

We are not talking about the small percentage of those in wretched situations.

We are talking about the hidden aspect of a BILLION DOLLAR industry designed to steal children, year, on year, often for no required reason - snatched ruthlessly from their homes, from schools, with their entire childhood they knew 'wiped away' as though it never existed ; the parents blocked from all communication.

Children who are wrongly abducted by these state departments are abruptly displaced 'like a commodity' into a foreign environment, blocking them from the love and care of their happy homes, their wishes ignored to return home and their loving parent is blocked from communicating with them...and yet, a society turns its back - due to the false brand name called 'child protective services';

There are horrifying testimonies of innocent children and loving, competent families, put through the terror of being hunted and robbed, and deprived of close kin bonds, causing elongated, torturous suffering, that cannot be adequately described... sometimes, the parent and child die from this torturous deprivation, persecution and separation loss.

Child protective services is the opposite to its brand name.

It is child harm. It is family harm.

It is a thief. And it is a lie.

Children ARE STOLEN WITHOUT NECESSITY - and NOT RETURNED

In simple terms, unsubstantiated claims are those that have not been proven, while substantiated claims or reports are those that are backed up by reliable evidence: the data to follow is from publicly available data showing a delineation of children removed from their homes which shows the delta (gap) of overall 'out of home' removals that are UNSUBSTANTIATED :

The most recent available government data showing the colossal number of children taken each year, on unsubstantiated claims

'5-year data analysis – 2022-2016: *alarming number of children displaced from their homes with no grounds; The specific data from this report shows that 45548 of 275 065 notifications were substantiated (allegedly); that means, 16 percent of all notification were deemed to be 'substantiated' (by their nebulous metric), Yet a staggering 61149 were still removed (stolen) from their parents care... which means 15601 children in one year alone were stolen from their safe, happy, loving homes - on groundless claims: unsubstantiated - yet kept anyway !*

That is 15601 children robbed from innocent parents: children that did not require to be removed at all - in one year alone - in our country !

each child brought into the system in Australia, becomes a "unit", an asset, [and] roughly equates to \$70,000 to \$150,000 per unit (child) in care annually. Special needs children are said to 'cost' (in services) up to \$350 – 450,000 annually; this is further supported by the NDIS. **The more children under guardianship... the more (tax) money is required, resulting in ever-increasing salaries and fees, and profit**

From the research in "The Child Protection Racket", it is estimated that \$70,000-\$350,000 of funding is handed down for each child 'stolen' in this industry.

If we look at that estimate for the data alone from the table above, on the most conservative scale, that is a BILLION-dollar figure; of \$1,092,070,000 of funding handed down one year of 'removals', with a minimum of \$624 million made from the component of unsubstantiated, absolutely unnecessary stealing of children.

If this staggering amount of money is made from just the portion of the classified 'unsubstantiated' child abductions – imagine how much profit is made by ALL those in this system – at the expense of innocent children, parents and their families ? Profit, bonuses, promotions... the list goes on...



That's the quantitative (calculable data) evidence... The qualitative, is an 'incalculable' loss for the child and parent:

When a 'notification' flies in through the portals of these departments, they're not interested in what a great parent you are; as that will get in the way of their objective. They have 'sales' goals and targets : so, it matters none that your child is perfectly safe, healthy, happy and loved with you – no, this business operation, fraudulently called 'child protection' - a notification allows these caseworker to make controversies out of that gossip - to benefit themselves. A **deaf ear is turned to innocent parent's truths and the voice of the child is also ignored**, when they say they wish to stay with their parent - **instead, the children are snatched ruthlessly - from their familiar, already safe, happy homes - done by these department workers, who then put the child at extreme risk in their unsafe government 'system' - PROVEN to cause children harm - this is abhorrent, and an absolute violation of the child and the parents rights**

So-called child protection are a serious risk of harm to this country : schools are in on it
children taken at the threat of gunpoint intimidation, without necessity: schools handing children over to complete strangers:
PUTTING THE CHILD AT RISK IN A VOLATILE GOVERNMENT SYSTEM

: depriving the child of the protection of their parents who are the REAL child protection

Corporations profit form this lucrative industry of child theft 'masquerading as 'child protection'
Horrific treatment of the child and parent by so called 'child protection' business workers:

School children are seized unaware by department 'caseworkers', at the threat of gunpoint intimidation, abruptly abducting children on lies and fabrication - immediately depriving the child of the love, care and protection of their parent

Following a 'notification' from a gossip report is a tsunami of terror experienced by the child and parent - who are hunted, stalked, harassed and intimidated, and the child 'then ambushed' and abducted by the threat of gunpoint intimidation - ruthlessly 'snatched' - and, these are good, competent, and often sole parents - who suffer elongated, torturous deprivation - an immense cruelty - all caused by these 'gossip report' and implemented by these 'department workers' - this causes the child and parent extreme trauma so excruciating, due to the sudden separation, robbery and subsequent wrongful persecution of the parent and deliberate isolation and alienation of the parent and child from each other. These department workers intentionally block the child and parent from communicating with each other - this is done for 'tactical advantage' - **and it is repugnant** - beyond adequate words.

The majority of 'removals' by what is STATE KIDNAP have been proven to be UNNECESSARY, and are following gossip reports of 'hearsay' - and the schools work with them to put children in danger in their 'system' - schools are handing children over to complete strangers!

Let us always remember that it is a private business making a profit for a firm: Parents are the REAL child protection

These departments are not about 'care' : They ruthlessly remove children screaming for their mums and dads - as they are dragged away at the threat of gunpoint - all done without necessity - from good, competent loving parents. .

Then, when the children are kidnapped by the state they are put in a foreign environment and the parent does not know where they are!:

The children often don't know where they are! Children are sometimes put immediately into a 'shared house' with volatile others.

By an ABC report a 10 year old girl was put into a home with older residents and a social worker admitted that the child was exposed to extreme danger by volatile others, and the child was abused, bullied and beaten by the older members of their state system 'of false care' following being taken from the parents 'real care'

These departments are stealing children from where they are absolutely fine at home, on the assumption of a caseworker with minimal life experience, on the back of 'nonsense gossip' - placing the child at risk in a volatile system, where the child is deprived of their parents protection :

We need to get the narrative right to the public: child protection services or whatever they call themselves, are not here to help – they care as much about children as a car thief cares about a car they steal to re-sell : they are STEALING CHILDREN TO PROFITEER A BEAST SYSTEM - all done on the 'public purse':

IT IS A BEAST SYSTEM - OF EVIL : 'deluded' self validating employees stealing children, then working with a judiciary who are networked to themselves - which is a conflict of interest. **People in these departments need to see what they are doing as well : it causes incalculable loss and elongated trauma that is almost incomprehensible unless one has lived through it**

A SYSTEM IS DESIGNED TO KEEP CHILDREN ON A '**REMOVE AND PLACE**' SYSTEM OF NO RETURNS.

Each year, thousands and thousands and thousands of children are taken on unsubstantiated grounds of what they call **UNKNOWN RISKS**

On average, 15,000 children are stolen every year from their homes in Australia on unsubstantiated grounds – yet still not returned home – just kept by the system

This information is mostly publicly hidden with mainstream media failing to report on the vast expanse of the cruel malpractice and mistreatment to Australian families caused by this industry of so called ‘child protection’ who are robbing loving, competent families of their children

The monstrous behaviour of these departments - stealing children by ambush - at the threat of gunpoint intimidation:

The hostile way in which this department treat children, and the parents they rob, is so horrific, (ruthless beyond a doubt); were children and their parents sometimes never recover from the trauma of being robbed of each other, children are stolen from where they are already safe and happy at home.

Caseworkers are fabricating risks - when there is no risk They are calling day to day family life - an ‘unknown’ risk

An ‘assumed risk’ by caseworkers, on a nonsense, does not make that a ‘risk’ (written by an under educated ‘case worker’ lacking a lot of ‘life experience’, with no respect for the parental role) The parental role is the true child protection and, a ‘system’ does not love

Children who are happy at home and are clearly not abused and wish to be at home need to be left in their safe homes

When children are abducted by these department workers, their communication devices (phones, computers) are stolen, and they are blocked from all communication with their parent.

This is a deprivation of the right of the child to freely call and seek support from their parent - and

This is a deprivation of the right of the child they have abruptly displaced into a foreign environment, sealing off their rightful opportunity to talk to their supportive parent.... depriving the child of the care and protection their parent.

And...then children are told lies about their parents, such as ‘there is something wrong with your mum’ – when there isn’t.

This is deliberately done to alienate the parent and child and so the child may ‘get used to’ the system

This industry of ‘so-called’ child protection is a heinous operation – and it is deliberate – it is a mauling of the family unit - and a violation of both the child and parent; and, mauling is the right word ; a psychological mauling, as the child is often ambushed, then displaced, by this lion-like beast industry, like a ‘commodity’as though their previous life ‘never existed’

**When children are stolen, a parent has no real chance in ‘their system’;
It is disgusting - repugnant;**

A risk needs to be real and make sense, which carries more risk than waking up each day and walking outside

Day to day normal family life is being called ‘a risk’ - when it isn’t;

Key decisions at the discretion of the parent raising the child – is not a risk - and gossip reports are hearsay - ‘gossip’, not a risk

Gossip reports are hidden and their credibility is not verified

Our children are not a profiteering model or a paycheck

This is a heinous operation of a BILLION DOLLAR industry

This government ‘child protection’ are a fraud : they have manipulated society on a mass scale - they harm children and families: they do not care about children any more than a car thief cares about a car they intend to steal and re-sell: and the schools work with them - handing over students to these predators, not notifying parents

These departments are adept manipulating family and the public to ‘oh they must have done something’ but in reality they haven’t :

Then the children are told lies about their parent such as, “you might not see your mum again” – leaving the child to sadly wonder ‘where is my mum or dad’- yet not told the truth that the parent has tried to reach them.

This is deliberately done – the longer they keep the child, the more opportunity they will have to manipulate the child and keep them ‘in the system’

Gossip reporters and all mandatory reporters’ - think twice: if the child is clearly not abused and it is a day to day parenting issue - talk to the parent - once you make that mandatory report you expose the child to this system for their life time: so-called ‘child protective services’ - are not child protection. you are therefore complicit and accountable for what you did;

‘child protection’ is not a friend to the child or family - they are a racketeering, profiteering industry that harms children and parents -

their system is the ‘known risk’

Intervening without necessity - overstepping the parental role

Nancy Schaefer discovered in her quest into the government system of profiteering of child-stealing there are MILLIONS of children who do not require any third-party interference, they are targeted and many, many corporations profit from this lucrative industry of child theft for profit... 'masquerading as child protection'

Australia is copying the CPS America child stealing program. In a scathing report written by Senator Nancy Schaefer on the Child Protective Services in America;

“(the state systems) are anti-family; they are anti-child “

“Children are taken from their beds in the middle of the night, from school buses, ambushed at their school”

- a horrific trauma for the child and parent and families

How dare these social workers be given ‘gunpoint intimidation’, to abduct our children

How deeply flawed is society to think a ‘government’ has a say in daily lives?

Children who are not abused at home - at all - are stolen and never returned

Deluded caseworkers asking the REAL parent for ‘input’ into a child’s life plan they are typing up the desk, weeks after the child is stolen, for no reason - yet still depriving all communication

there is something very, very, very wrong about this.....and the people need to see it.....it needs to stop

There is a delineation between day to day parenting or the child not doing their homework, not getting vaccinated, or parental decisions in raising the child - this is not a risk of harm

Normal, day to day parenting and key decisions are at the discretion of the parent raising the child to support them – a risk!

Gossip and hearsay - is not a risk! It is gossip and ‘out of scope’ to a government ‘ a government is not part of the parenting ; this is a totalitarian control and the most ‘insane’ level : where there is no neglect or abuse or harm - these departments say : ‘unknown risks’ and the ‘assumption of risk’ based on unverified gossip.

Children declare they are happy are taken anyway and the parent is persecuted - it is madness !

These departments incomes rely on those who would like to see the parent and child relationship ruined: exploiting the ‘maliciousness’ of people in society - to steal children on gossip....taking the word of a vengeful individual -

Gossip reporter credibility never tested...the veracity of the gossip or school not tested...the child is simply stolen.... the ‘immature caseworker’ makes up a fabrication...the child and parent caused immense trauma, children distracted by being buttered up with money and lies such as ‘there is something wrong with your mum’ - when their isn’t - at all. It is madness.

“ it can be months, even years before parents can defend themselves due to these perverse incentivised state businesses, called Child Protection

Evidence : Caseworkers lie in reports to steal children

The following interview shares a real-life story about child protection caseworkers ‘making things up for **tactical reporting meaning these department caseworkers lie, deceive and obfuscate - to ‘steal children’**

Jeff Berwick of Nova Om interviewed a mother who had her 6 year old child taken away by a social worker - where the caseworker flat out lied in a report to steal the child:

The child was signed off by the doctor ‘**okay to go home**’ but the Child Protection agent who intercepted that report – and wrote in the ‘child protection reports’ that at the child was in immediate danger and at an ‘extreme risk of illness’ – and blamed the mother for negligence, yet this was found to be a lie, the doctor had actually written that the ‘child was free to go home the same day’.

In an encounter with so-called child protection trying to take her children the mother said
“my kids screamed and ran over and we’re clinging to me”

“ the caseworker kept my daughter... then presented to the court that my daughter was in a fragile medical condition and had to be at the hospital so ... the court kept my daughter based on the caseworkers ‘assessment’ ... that my daughter was in some kind of medical condition, due to her type one diabetes on my negligent care”

Yet, this was found by the court to be an outright lie made by the caseworker

....and the mother did not get her daughter back for months

based on the lies of the child protection case worker, evil, falsified reports

Running with nonsense allegations and persecution on ‘hearsay’

Manipulating and keeping hostage the child and persecuting the parent :

Liken to the old witch hunts this system is tyrannical and morally wrong, yet people turn away from supporting the family robbed of their precious child due to the indoctrination by ‘societal menticide’ due to the gaslighting narrative of falsely branded ‘child protection services’ – when it is doing the opposite;

20 PERCENT OF THE AUSTRALIAN POPULATION CHILDREN 0-17 HAS BEEN CONSUMED BY THIS SYSTEM since 2006, over 1 MILLION of OUR CHILDREN at 50,000 per year.

Make no mistake: this private corporation government system is a profiteering business called ‘child protection’ it is designed to “seize” children, where children are presumed as chattel, with a sales notice of ‘listing’ in their hideous marketplace called ‘children’s court or youth court’ : it’s all about money, and control, and it is demonic.

This department is a for profit private corporation making profit for their firm.

Daily in Australia, a parent and child are hunted, stalked and intimidated by stealth, and are robbed of each other, by the self-entitled private corporate department agents empowered with delusional confidence, instilled by system-Masters: the grotesque industry ‘beast’ called Child Protective Services.

This is a vindictive, evil harm this department causes to the child, the parent and society - yet for this to still be ignored in society, is an example of the brainwashing of society called ‘Menticide’, when an evil is called ‘good’ – when it is not.

One only needs to ask anyone who has had their child removed without substantiated reason; You will see the toll of trauma in their gaze, from the terror of the stealth operation, the extremity of being alienated, and persecuted, aghast by the manipulation effect of the false narrative on a society, gradually depleted within the inertia of the societal psychosis, called 'menticide'.

The child was then placed and signed over without consent, with no information supplied, despite those requests. No information was ever sent to the mother, even when the mother requested that the court supply this 'in writing' so she may respond. Two court hearings were held behind the mothers back, with this non-disclosure:

On the back of gossip and false allegations and a school report, the child was visited at her school by child protection 'agents' and the child was forced against her wishes by a teacher to speak with them (the child said she didn't want to talk to them). The 14-year-old politely told the predatorial so called 'child protection' agents that she was fine and didn't require them.

The child became increasingly fearful and felt intimidated by predatory agents and expressed to police she did not want these people to take her away from where she felt safe, happy and loved, at home with her mum. She also confirmed that she did not know these people and wanted these people to go away and leave her in peace. The police took the time to take the report, and then forwarded that report to the Child Protective Services to 'self-manage' (they self-manage complaints about themselves). On the very next day, on the last day of school term, the very people the child complained about ambushed her at her school, her phone and bag taken - state kidnap by ambush at her school when they knew the mother was not there to protect her....the school did not notify the mother at any time this was occurring. All her mother got was an 'sms' from the child snatchers, saying 'your child will not be returning home tonight..... **her mother has not seen her daughter, ever since.**

What the mother and daughter did not know at the time was the effect of a tri-agency agreement which is why the police at state level could not get her daughter; they are bound to a tri-agency agreement called: Joint Intent: The 'JOINT INTENT' where the Minister of education and Minister of child stealing (child protection industry), signed an agreement together with head of police to back them up whenever they wanted to steal a child; to form a strategic program called the Magellan Program: (see Joint Intent and Magellan Program): Therefore, the police could not help. The government and the court did not help either: The mother wrote to the court, The Commonwealth Ombudsman, The Prime Minister and The Attorney-General and requested that information be supplied to her, but this was ignored. Two courts ran behind her back, her child 'stolen' – just like that. The mother said the trauma was so frightening, she said 'she wouldn't wish it on anyone, not even those who did this' – that's how bad it was - grief beyond words. In over 6 months this department has not at any time communicated her daughter's welfare and has blocked communication –

This is one of many devastating, horrendous stories. In another example a woman had two of her daughters removed, as she was accused by the ‘school mandatory reporting system’ that she made up a ‘gluten allergy’ for her children; she did not see her daughters for 5 months:

Last financial year, SA's Department for Child Protection removed 105 babies, aged under one month, from their mothers.

-Damning claims by an SA government whistleblower have been leveled against the way child protection authorities are removing newborns from their mothers at public hospitals **“She said she no longer wanted to stay silent about what she described as “inhumane” practices. “We don’t treat them [the mothers] like human beings.”** the public servant said... see above link for article.

- List varies by 're-branding' of their deceptive trade names over time, masking their crimes while they all have their own ABNs, a Private Corporate Business, for profit.

Analysis summary::

This is a rogue industry with caseworkers fabricating information for strategic intent to steal children, then displacing them 'like a commodity' in a foreign environment, ready for commercial processing in a lucrative system: where caseworkers have a job, their managers have a job, magistrates have a job, lawyers get paid (win or lose), non-required independent assessors have a job, foster carers are paid and the list goes on...all at the expense of children and parent suffering - stolen from their happy homes without necessity - meaning where they were was a safe home with love, with their parents, third party involvement from schools and these people from these departments is not required and does not supersede family.

Too much power is given to these departments, who are not impartial - because this is a 'business' where a system profits,

Hostile department caseworkers display repugnant behaviour toward the rights of children and their parents and are empowered

Babies are taken from the birthing table and later found caseworkers relied on falsified evidence from years and years, prior to the birth of the baby, the mother was and is competent and even after this was proven, the baby was put into the system by a judge until 18 years of age. (See evidence Pg 38).

It has been evidenced that when older children wish to go home, their requests are ignored and they are denied their right to talk to their parent, to enjoy the rightful love and care available to them by their parents and kin they have been alienated from.

Children are psychologically traumatised by the sudden ambush at the threat of gunpoint with intimidation : they are kidnapped, held hostage and taken to a foreign environment to wonder 'where is my mum or dad' then told lies about their parents for example that the parents are unsafe and under investigation.

It has been evidenced that children as young as 6 cry in the middle of the night, after being stolen, asking for their parents - and are told 'their parent may not return'. Distressed children are told to distract themselves when they feel upset and are longing to go home to their family.

In truth, the parent is trying to reach their children, but these departments control and block all communications - no phone calls or visits or even messages can get through to the child who then feel abandoned - this is intentionally done by these departments to try and dissolve the child - parent bonds. Most parents are likely unable to navigate through this horrendous pain and persecution - designed to emotionally cripple and alienate the parent - while keeping the child 'in their system';

Their risks reports operate on a system of caseworker fabrications and not requiring evidence - by an assumption of so called 'issues' made up by departments - from unverified gossip reports - in the **UNSUBSTANTIATED category**.

An issue made up by a department is not necessarily an 'issue' for the child or parent particularly if they both say there is none. Social workers can be on a 'power trip' because they get away with this 'with no recourse' - nobody is calling them to account.

They create controversies to 'keep a job' - and this needs to be brought to the attention of this nation; they are not the parent, and they don't listen to the parents.

Schools are not parents and they make reports without discussing their 'opinions' with the parents. Social workers (or caseworkers) conveniently create 'issue' to validate their job; an opinion of a department does not automatically become a 'risk' just because a department says it is: **the reality of a 'risk' must be measured as a risk, and not an imagined risk - these departments overstep the parental role.**

The horrific process of these removals with the agents and caseworkers, wrongly empowered, strolling into your private property and schools without proper cause or court order, knowing they may call armed police with terror, to achieve their business objective of child stealing - whenever they like is what is actually happen now in this nation . There are some good police in the force - and they are appreciated - however they must realise this is a terrifying thing for children, and especially sole parents.

The cruelty this causes children and families is inhumane: causing a trauma so excruciating by the sudden separation, abduction of the child and subsequent persecution, deliberate isolation and alienation of the parent and child/children - who are often never returned - **they often never recover...**

These departments called 'Child Protection' are a rogue profiteering operation with zero accountability and have been proven to harm innocent children and good, loving parents, causing incalculable loss and grief and elongated suffering to children and families of Australia -

I served in the Georgia state senate and after four years of viewing the ruthlessness, CPS has redefined poor to mean psychologically inferior therefore it is in the best interest of the child to be removed : ***“best interest” - of course has also been redefined at the child’s expense:***

“It has been reported over and over that six times as many children die in foster care than in the general public.”

Once a child is legally kidnapped and placed in ‘official safety’, the child is far more likely to suffer abuse including sexual molestation and or rape and case workers and social workers are often guilty of fraud; they withhold and destroy evidence and they seek wrongly to terminate parental rights while being protected by state immunity.

“ There is a huge bureaucracy made up of judges, court appointed attorneys, social workers, state employees, court investigators, therapists, psychologists, psychiatrists, foster parents, adoptive parents and on and on who are looking to the children in state care for their job security “

“Judges have control over private living arrangements and income of \$ 48.3 million USD”

... census bureau reported in 2002 that **\$40 billion** in transfer payments were made between households of custody parents and other parents, that money \$40 billion is under the direction and control of family court judges in environments covered with **confidentiality laws that protect the wrong people:** fathers are victims of this unjust system child support payments even without having visits with their children, and are choking the very life out of fathers - *three fathers of whom i am aware and have been in touch with, committed suicide in the last 12 months because they lost the opportunity to even visit with their children.*

These are crimes against humanity for financial gain.

Rights are removed from parents human rights, civil rights, and even religious rights.

One illustration of what took place in my district is that after so many calls, I decided to call a meeting in one of the counties of my own district. I personally called 37 families that had been in touch with me who had all lost their children, grandchildren. I had them meet me in the library one Saturday morning: we started at nine o’clock and we ended at nine o’clock. We had 50 families standing outside the door that could not get in , we didn’t have time to talk with them.

There was incredible anguish and profound suffering from these families some children had been taken off the school bus taken out of the hospitals or taken out of their homes in the middle of the night and even worse it was just an incredible ordeal these parents trapped in the system become like refugees they're dazed and glazed and have no one of whom to turn they do not know what to do and the loss of their children is devastating after having worked in this arena for several years.

"I do not believe that a single child comes out whole after having been in this system many foster children make up the homeless population of today."

I introduced legislation senate bill in my last session a substitute bill was written at the last minute by the Chairman of the judicial committee all the strong points of my bill had been compromised: I was told accept it senator at least you will get your legislation passed and I answered with;

"obviously you do not know me, I did not come to the capitol to get legislation passed, I came to make a difference."

What can be done?

- **An independent audit should be called on every state of all child-protective services departments**due to the hundreds upon hundreds of cases that I've been called to consider I called to state senators representatives in their respective states across the country asking them to help me with certain families and was told:

"if I help that family or if I help you I will lose my job"

- **remove abolish the federal and state financial incentives** - those are taxpayer dollars those dollars have turned CPS into a business that takes children and separates families for money.
- **give parents their rights** verbally and in writing to terminate the rights of parents the **case should be heard before a jury - Family rights and parents rights must be protected.**

**"We do not need more influence like the UNITED NATIONS convention on the rights of the child (because)
" it's anti-parent, anti-child and anti-common sense for the family "**

There has to be perseverance for any great reform. and great reform is needed in this area, as Charles Spurgeon put it; *"how do you tame a lion that is well fed ? first he must be brought down, second his stomach must be lowered"*

THE CORRUPT BUSINESS OF CHILD PROTECTIVE SERVICES

My introduction into Child Protective Service cases was due to a grandmother in an adjoining state who called me with her tragic story. Her two granddaughters had been taken from her daughter who lived in my district. Her daughter was told wrongly that if she wanted to see her children again she should sign a paper and give up her children. Frightened and young, the daughter did. I have since discovered that parents are often threatened into cooperation of permanent separation of their children.

The children were taken to another county and placed in foster care. The foster parents were told wrongly that they could adopt the children. The grandmother then jumped through every hoop known to man in order to get her granddaughters. When the case finally came to court it was made evident by one of the foster parent's children that the foster parents had, at any given time, 18 foster children and that the foster mother had an inappropriate relationship with a caseworker.

In the courtroom, the juvenile judge, acted as though she was shocked and said the two girls would be removed quickly. They were not removed. Finally, after much pressure being applied to the Department of Family and Children Services of Georgia (DFCS), the children were driven to South Georgia to meet their grandmother who gladly drove to meet them.

After being with their grandmother two or three days, the judge, quite out of the blue, wrote up a new order to send the girls to their father, who previously had no interest in the case and who lived on the West Coast. The father was in "adult entertainment". His girlfriend worked as an "escort" and his brother, who also worked in the business, had a sexual charge brought against him.

Within a couple of days the father was knocking on the grandmother's door and took the girls kicking and screaming to California.

The father developed an unusual relationship with the former foster parents and soon moved to the southeast. The foster parents began driving to the father's residence and picking up the little girls for visits. The oldest child had told her mother and grandmother on two different occasions that the foster father molested her.

To this day after five years, this loving, caring blood relative grandmother does not even have visitation privileges with the children. The little girls are, in my opinion, permanently traumatized and the young mother of the girls was so traumatized with shock when the girls were first removed from her that she has never completely recovered. The mother has rights but the father still has custody of the children.

Throughout this case and through the process of dealing with multiple other mismanaged cases of the Department of Family and Children Services (DFCS), I have worked with other desperate parents across the state of Georgia and in many other States because their children were taken for no cause and they have no one with whom to turn. I have witnessed ruthless behavior from many caseworkers, social workers, investigators, lawyers, judges, therapists, and others such as those who “pick up” the children. I have been stunned by what I have seen and heard from victims all across this land.

In this report, I have focused mainly on the Georgia Department of Family and Children Services (DFCS). However, I believe Child Protective Services nationwide has become corrupt and that the entire system is broken beyond repair. I am convinced parents and families should be warned of the dangers.

The Department of Child Protective Services, known as the Department of Family and Children Services (DFCS) in Georgia and other titles in other states, has become a “protected empire” built on taking children and separating families. This is not to say that there are not those children who do need to be removed from wretched situations and need protection. However, this report is concerned with the children and parents caught up in “legal kidnapping,” ineffective policies, and an agency that on certain occasions would not remove a child (or children) when the child was enduring torment and abuse.

In one county in my District, I arranged a meeting for thirty-seven families to speak freely and without fear. These poor parents and grandparents spoke of their painful, heart wrenching encounters with DFCS. Their suffering was overwhelming. They wept and cried. Some did not know where their children were and had not seen them in years. I had witnessed the “Gestapo” at work and I witnessed the deceitful conditions under which children were taken in the middle of the night, out of hospitals, off of school buses, and out of homes. In one county a private drug testing business was operating within the agency’s department that required many, many drug tests from parents and individuals for profit. It has already made over \$100,000.

Due to being exposed, several employees in this particular office were fired. However, they have now been rehired either in neighboring counties or in the same county again. According to the calls I am now receiving, the conditions in that county are returning to the same practices that they had before the light was shown on their evil deeds.

Having worked with probably 300 cases statewide, and now hundreds and hundreds across this nation and in nearly every state, **I am convinced there is no responsibility and no accountability in Child Protective Services system.**

I have come to the conclusion:

- that poor parents very often are targeted to lose their children because they do not have the where-with-all to hire lawyers and fight the system. Being poor does not mean you are not a good parent or that you do not love your child, or that your child should be removed and placed with strangers;
- **that all parents are capable of making mistakes and that making a mistake does not mean your children are to be removed from the home. Even if the home is not perfect, it is home; and that’s where a child is the safest and where he or she wants to be, with family;**
- that parenting classes, anger management classes, counseling referrals, therapy classes and on and on are demanded of parents with no compassion by the system even while the parents are at work and while their children are separated from them. (some times parents are required to pay for the programs) This can take months or even years and it emotionally devastates both children and parents. Parents are victimized by “the system” that makes a profit for holding children longer and “bonuses” for not returning children to their parents;
- **that caseworkers and social workers are very often guilty of fraud. They withhold and destroy evidence. They fabricate evidence and they seek to terminate parental rights unnecessarily. However, when charges are made against Child Protective Services, the charges are ignored;**
- that the separation of families and the “snatching of children” is growing as a business because local governments have grown accustomed to having these taxpayer dollars to balance their ever-expanding budgets;
- **that Child Protective Services and Juvenile Court can always hide behind a confidentiality clause in order to protect their decisions and keep the funds flowing. There should be open records and “court watches”!**

Look who is being paid!

There are state employees, lawyers, court investigators, guardian adlitems (as in a child’s lawyer), court personnel, and judges.

There are psychologists, and psychiatrists, counselors, caseworkers, therapists, foster parents, adoptive parents, and on and on. All are looking to the children in state custody to provide job security.

Parents do not realize that the social workers are the glue that hold “the system” together that funds the court, funds the court appointed attorneys, and the multiple other jobs including the “system’s” psychiatrists, therapists, their own attorneys and others. Continued next page...



- that The Adoption and the Safe Families Act, set in motion first in 1974 by Walter Mondale and later in 1997 by President Bill Clinton, offered **cash “bonuses”** to the states for every child they adopted out of foster care. In order to receive the “adoption incentive bonuses” local child protective services need more children. They must have merchandise (children) that sells and you must have plenty so the buyer can choose. Some counties are known to give a \$4,000 to \$6,000 bonus for each child adopted out to strangers and an additional \$2,000 for a “special needs” child. Employees work to keep the federal dollars flowing;

- State Departments of Human Resources (DHR) and affiliates are given a baseline number of expected adoptions based on population. For every child DHR and CPS can get adopted, there is the bonus of \$4,000 or maybe \$6,000. But that is only the beginning figure in the formula in which each bonus is multiplied by the percentage that the State has managed to exceed its baseline adoption number. Therefore States and **local communities work hard to reach their goals for increased numbers of adoptions for children in foster care.**

- that there is double dipping. The funding continues as long as the child is out of the home. There is funding for foster care then when a child is placed with a new family, then “adoption bonus funds” are available. **When a child is placed in a mental health facility and is on 16 drugs per day, like two children of a constituent of mine, more funds are involved and so is Medicaid;**

- As you can see this program is ordered from the very top and run by Health and Human Resources. This is why victims of CPS get no help from their legislators. It explains why my bill, SB 415 suffered such defeat in the Judicial Committee, why I was cut off at every juncture. Legislators and Governors must remember who funds their paychecks.

- **that there are no financial resources and no real drive to unite a family and help keep them together or provide effective care;**

- that the incentive for social workers to return children to their parents quickly after taking them has disappeared and who in protective services will step up to the plate and say, “This must end! No one, because they are all in the system together and a system with no leader and no clear policies will always fail the children.

Just look at the waste in government that is forced upon the tax payer;

- that the “Policy Manuel” is considered “the last word” for CPS/DFCS. However, it is too long, too confusing, poorly written and does not take the law into consideration;

- that if the lives of children were improved by removing them from their homes, there might be a greater need for protective services, but today children are not safer. **Children, of whom I am aware, have been raped and impregnated in foster care;**

- It is a known fact that children are in much more danger in foster care than they are in their own home even though home may not be perfect.

- that some parents are even told if they want to see their children or grandchildren, they must divorce their spouse. Many, who are under privileged, feeling they have no option, will divorce and then just continue to live together. This is an anti-family policy, but parents will do anything to get their children home with them. However, when the parents cooperate with Child Protective Services, their behavior is interpreted as guilt when nothing could be further from the truth.

- Fathers, (non-custodial parents) I must add, are oftentimes treated as criminals without access to visit or even see their own children and have child support payments strangling the very life out of them;

- that the Foster Parents Bill of Rights does not stress that a foster parent is there temporarily to care for a child until the child can be returned home. **Many foster parents today use the Foster Parent Bill of Rights as a means to hire a lawyer and seek to adopt the child placed in their care from the real parents, who are desperately trying to get their child home and out of the system.**

Recently in Atlanta, a young couple learning to be new parents and loving it, were told that because of an anonymous complaint, their daughter would be taken into custody by the State DFCS. The couple was devastated and then was required by DFCS to take parenting classes, alcohol counseling and psychological evaluations if they wanted to get their child back. All of the courses cost money for which most parents are required to pay. While in their anxiety and turmoil to get their child home, **the baby was left for hours in a car to die in the heat in her car seat by a foster parent who forgot about the child. This should never have happened. It is tragic.** In many cases after the parents have jumped through all the hoops, they still do not get their child. As long as the child is not returned, there is money for the agency, for foster parents, for adoptive parents, and for the State.

- that tax dollars are being used to keep this gigantic system afloat, yet the victims, parents, grandparents, guardians and especially the children, are charged for the system’s services.

- that grandparents have called from all over the State of Georgia and from other states trying to get custody of their grandchildren. CPS claims relatives are contacted, but there are many many cases that prove differently. Grandparents who lose their grandchildren to strangers have lost their own flesh and blood. The children lose their family heritage and grandparents, and parents too, lose all connections to their heirs.

• that The National Center on Child Abuse and Neglect in 1998 reported that **six times as many children died in foster care than in the general public and that once removed to official “safety”, these children are far more likely to suffer abuse, including sexual molestation than in the general population.** Think what that number is today ten years later!

• That according to the California Little Hoover Commission Report in 2003, 30% to 70% of the children in California group homes do not belong there and should not have been removed from their homes.

RECOMMENDATIONS

1. Call for an **independent audit of all State Child Protective Services (CPS) and for a Federal Congressional hearing on Child Protective Services nationwide.**

2. Activate immediate change. Every day that passes means more families and children are subject to being held hostage and their lives destroyed.

3. Abolish the Federal and State financial incentives that have turned Child Protective Services into a business that separate families for money.

4. Grant to parents their rights verbally and in writing.

5. Mandate a search for family members to be given the opportunity to adopt their own relatives if children need to be removed permanently.

6. **Mandate a jury trial where every piece of evidence is presented before permanently removing a child from his or her parents. Open family court. Remove the secrecy. Allow the press and family members access. Give parents the opportunity in court to speak and be a part of their children’s future.**

7. **Require a warrant or a positive emergency circumstance before removing children from their parents.** (Judge Arthur G. Christean, Utah Bar Journal, January, 1997 reported that “except in emergency circumstances, including the need for immediate medical care, require warrants upon affidavits of probable cause before entry upon private property is permitted for the forcible removal of children from their parents.”)

8. **Uphold the laws when someone fabricates or presents false evidence. If a parent alleges fraud, hold a hearing with the right to discovery of all evidence made available to parents.**

FINAL REMARKS

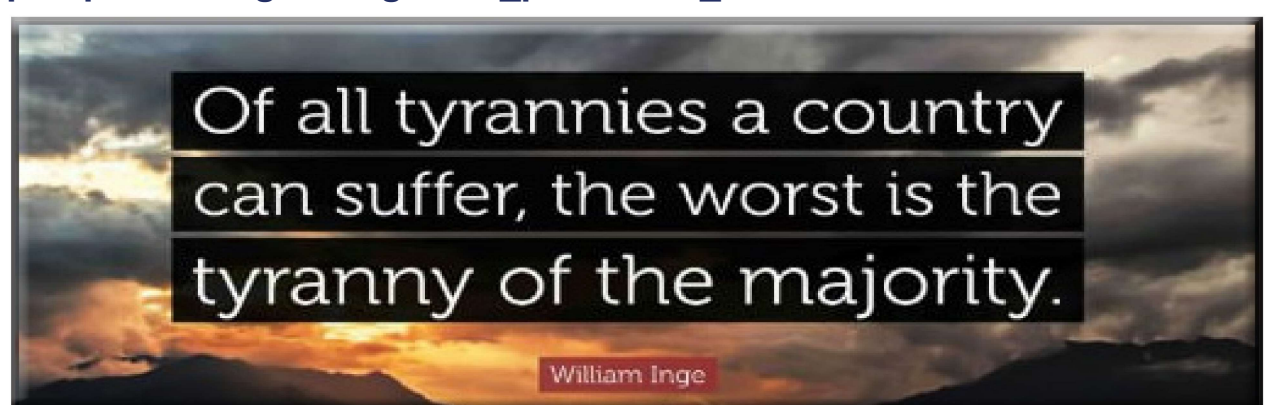
On my desk are scores of cases of **exhausted families and terrified children.** It has been beyond me to turn my back on these suffering, crying, and beaten down individuals. We are mistreating the most innocent. Child Protective Services have become an adult centered business to the detriment of children. No longer is judgment based on what the child needs or who the child wants to be or with whom, or what is really best for the whole family; it is some adult or bureaucrat who makes the decisions, based often on just hearsay, without ever consulting a family member, or just what is convenient, profitable, or less troublesome for the social workers.

I have witnessed such injustice and harm brought to so many families that **I am not sure if I even believe reform of the system is possible!** The system cannot be trusted. It does not serve the people. It obliterates families and children simply because it has the power to do so.

Children taken without necessity :

As Mr Burton continues his crusade against what he claims are excessive child out-of-home care systems operating not just in this state, but in other jurisdictions around the country, he prefers to refer to them as **kids for cash” programs**.

The former secretary of the Church of Ubuntu outlines that not only are **children being removed from their families for unjustified reasons**, but there's a **whole network of organisations profiteering from the placing of children in out-of-home care**.

Sydney Criminal Lawyers spoke to Paul Robert Burton about why's he so persistent in his fight against these matters, how he conceives this child removal profiteering system is operating, and how he advocates that meaningful change can be brought about

Paul, how would you sum up why you've been attending court to such a degree of late. And as some of these matters are still ongoing, how would you say you've fared so far?

PRB:

I'm doing it for the sake of all of our children, because what we are up against is probably one of the most draconian and sickest things I have ever encountered in my life. My biggest struggle has been trying to get politicians, and various senior representatives of our community, to talk about these issues that are so profound and horrific that it's almost impossible to get people to address. And it's affecting thousands.

You're raising criticisms around the NSW child welfare system. You go as far as to describe it as a “kids for cash” program. Can you elaborate on why you describe it this way?

When a child is taken by the state – let's say FACS NSW (now rebranded to Department of Communities and Justice, DCJ) – a **normal healthy child is worth about \$40,000 of taxpayers' money**.

FACS are privatising the out-of-home care system. So, when a child is taken, it no longer looks after that child. The department outsources the child to one of several other paths – out-of-home care or residential care – it depends on the situation.

But, the child goes to a third party. And they take taxpayers' money. So, for a normal child, they fork out around \$40,000. That goes to one of these organisations. A highly compromised child was worth about \$325,000 a year in 2016. So that's probably more now.

The more compromised the child is, the more money they're worth. And they pay that to these third parties that apparently operate in the children's best interests. That's the simple way of explaining it.

The NDIS has a huge responsibility in this as well.

The funding of the NDIS, in my view, has some very serious questions to answer.

But, nonetheless, fundamentally what's happening is Family and Community Services has no financial incentive to look after a child and keep a child with a family.

They're 100 percent geared to removing a child under any circumstances. And they call it “the permanent placement principle”, under the child protection act, which I might add is a genocide act.

They remove these children, and the sicker they are, the more money they're worth. The more they're diagnosed with ADHD or other conditions, the more complex it gets and the more money they're worth.

It's because we live in a world driven by money, and our children have become nothing more than financial units to these corporate interests.

That's why we call it cash for kids.

We have numerous examples to show how these funds run through to various pecuniary interests that have nothing to do with a risk of significant harm, or the best interest of a child.

A chapter from the book:

THE CHILD PROTECTION RACKET

Australia participated in the trade of 'importing' so-called convict children (as young as 13) from Britain and Ireland. The suspicion of petty larceny (theft under one shilling) was enough to send you packing. Australia was paid to take them, and children were expected to work on arrival. This human resource transfer was facilitated by the Transportation Act 1717, from around 1788 to 1868.

Then in 1869, coincidentally, the focus turned to the First Nations peoples, with the 'Act to provide for the Protection and Management of the Aboriginal Natives of Victoria'. The state (of Victoria) had already prepared the way through The Neglected and Criminal Children's Act 1864 (No.216) -- the first piece of legislation in Victoria to define how children might be removed from their parents. The 1869 Act was later amended to the Aborigines Act 1890.[i] "This new legislation continued the Protection Board's power to remove children to and from 'stations' [missions...], orphanages... [etc.]" Stolen Generation testimonials give some idea of the calamitous so-called 'protection' outcomes:

"You're going to be here for the rest of your life, like the rest of us... You won't see your mother anymore."

(Netta, Stolen Generation Stories[ii]) The authorized power, the 'Protection' Board, did everything but protect. (Note the incongruous use of the word 'protection'.) The country was expert at "stealing" children, legally; and yes, can now refer to these children as being 'stolen'.

Oh, be heartened though (cough): in 2008 Prime Minister Kevin Rudd gave a formal apology to the "Stolen Generations" whose lives "had been blighted by past government policies of forced child removal" from their families from the mid-1800s to the 1970s. But like an infomercial: wait there's more!

From the 1920s to 1970s, under the Child Migrant Program (a population-labour scheme) more than 130,000 children were sent to a "better life" in former colonies, mainly Australia and Canada. Mostly sourced from deprived families, the fortunes of these children aged between three and 14 varied. Many suffered lonely and brutal childhoods. And as one scheme abated, another child "remove-and-place" program replaced it. I quote from Victoria's DHHS (Department of Health and Human Services) records.[iii] "During the 1950s and 1960s, the community services sector experimented with foster care" in the general population, with concerted publicity campaigns to recruit foster carers through the 1960s. "By the 1970s foster care was defined as a service enabling the placement of a child or children with a selected family for a planned period while work occurred with the natural family towards the child's return home or to a permanent placement."

I'm sure there were serious attempts to improve the lives of children in the general population (to phase out orphanages and institutions, and children neglected at home) -- but like the old proverb, "The road to hell is paved with good intentions." Corrosive concepts and ideals would override good intentions into exploitation.

By the 1970s, 'child protection' had moved on from the First Nations to protecting all children. The Children and Young Persons (Care and Protection) Act (157/1998) provided "for the care and protection of, and the provision of services to, children..." and this created the contemporary systems we know. The Child Protection Act 1999 (Qld) outlined "best interests" of the child as the main principle.

Sadly, in so many instances, it seems the courts functioned on "worst interests."

In the mid-70s, The Family Law Act 1975 (Cth) (FLA) set out how to manage custody and "child protection concerns" in Federal Family Law courts. This initiated a legal mechanism to settle custody disputes through an adversarial court process.

There's a jurisdictional twist with regard to the 'protection' of children. Family Court (Federal legislation) is the superior jurisdiction, but in Australia it is subservient to the State courts when it comes to child protection and State child protection orders.

This is through s69ZK of the Family Law Act 1975, where nothing in the Act affects the operation of a child welfare law in relation to a child. This means that the lower Children's Courts have the "controlling interests" in the trade of children.

Maybe you haven't grasped this concept yet, but it will soon become clear. The child removal departments use the law, as governments did before them over hundreds of years, to remove children. And, they have the words "protection" and "safety" to guile you. For example, The Department for Child Protection SA (DCP) uses The Children's and Young People's Safety Act, 2017 (CYPS Act) to abduct a child from families, and from the federally ordered and lawful care of mothers and fathers.

When I was riding around the central desert of Australia,

I spoke to an emergency nurse about this book. She explained her experience with child protection services was the opposite of what I was describing. When, as a mandatory reporter, she'd come across a child in need of help (rescue) she'd make a report. She said nothing was ever done, and that the department would only act for that child after six of seven serious reports. (When I say "department", I am referring to the child protection department of that specific State.) **Why would public servants (social workers) do absolutely nothing in some serious cases -- yet in others intervene aggressively to claim guardianship of a child on the flimsiest of information? I find this puzzling, but essentially the outcome for the child is irrelevant as this is just a business.**

This chapter is about the 'child stealing' business, and how society, government and the law have presented this as acceptable practice. It's not acceptable and makes the Bringing Them Home report in 1997 and the 2008 "sorry" apology to the Stolen Generations a farce.

Has the Stolen Generation ended? The NSW FACS (the Department of Communities and Justice, DCJ) Annual Report 2019-2020 under the section[iv], 2.6 'Children and families thrive' states: "During 2019-20, caseworkers brought 2,206 children into care... This included 952 Aboriginal children, an increase of 2.4 per cent as compared with 2018-19."

The use of "thrive" is interesting! 952 Aboriginal children out of 2,206 were brought into care in one year? That's 43% of children from only 3.4% of people in NSW who identified as Aboriginal and/or Torres Strait Islander in the 2021 Census.

Thus, are the anecdotal stories I have been told true?

Pastor Paul Robert Burton has researched this for many years and has detailed how certain agencies have gone into Aboriginal communities to vacuum up 20 to 30 children over a long week-end as if they were on a self-endorsed quota system. Is this a revised contemporary version of the 'stolen generation'? I also recently received a substack post[v] by Josephine Cashman that read (extract[vi]): "I'm a whistle-blower. I served under 2 Prime Ministers providing independent advice. I uncovered a child trafficking and drug supply network. Resulting in child suicides, caused by an untouchable government funded crook of the Uluru Voice Con."

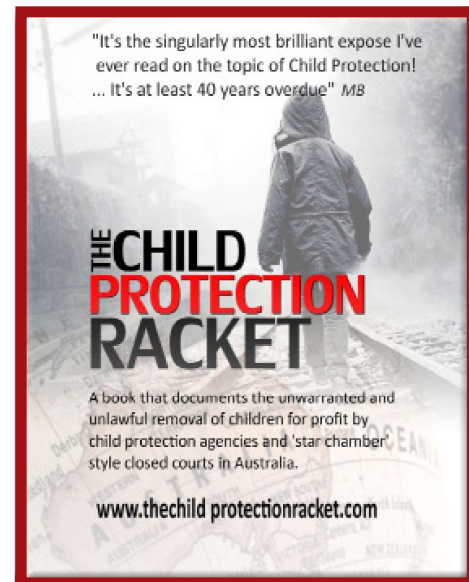

In my recently published book, **THE CHILD PROTECTION RACKET**, I attempted to be temperate in my accusations and claims that Australia was a child stealing and child trafficking nation. This is about a mother I call PJ. I briefly covered her story in the book, but as the case progressed, it became more and more obvious that this is an example of George Orwell's *Nineteen Eighty-Four* unfolding in 2024.

Recently, a professional in the field of psychotherapy said to me, *"You would have disordered thinking if you believed the government was not corrupt in some way."*

Nineteen Eighty-Four became an instant classic when published in 1949 and with memories of a Nazi dictatorship, people could see then that this could become a reality. One of Orwell's innovations was "Newspeak" where "Thoughtcrime" was punishable — i.e., it would be illegal to have thoughts that are in opposition to the 'Party'—yes, good old thought crime. **Now in Australia, if you believe the government is corrupt your child can be removed from your care. Permanently.** Yes, please reread that again.

Pastor Paul, myself, and a few others are across about 200+ cases — but rarely have we seen such a level of court obfuscation, department malice, and medical malpractice play out as in this case.

I've met her many times over several months. I've seen videos of her and her 4-year-old son having a happy time traveling the country; then she made a report on government corruption in early May 2023 (from South Australia). A call comes through from some Victorian government office. **"We warned you (in 2019) not to do this again... we want to sight your son."**

Well, I'm sure you know what happened next. A police unit located her, and in what was described to me as a very violent and forceful detainment, her son was ripped from her care. It took three officers to prize the screaming child from his mother. She has not seen him since.

PJ was very vocal in court — so a magistrate passed judgment that she required a Litigant guardian. This is denying the mother the natural right to voice a defence, as the Litigant guardian is going along with the wishes of the state government — i.e., to remove the child permanently into state care until he's an adult.

I reported the case to CARL (Child Abuse Report Line) — stating **that the government had psychologically abused the child through a forced and violent removal.**

The science is clear on this — it changes the brain when a child is removed from a loving parent.

And, I said to the woman, if the department claims the child is now happy — this could very well indicate that the child's brain has dissociated from the trauma — and that he is already mentally harmed.

We know that this drastically affects life's outcomes. We spoke for close to 40 minutes, and she became very empathetic to the plight of the child.

But it seems that in the business of removals there is a NO RETURN POLICY.
