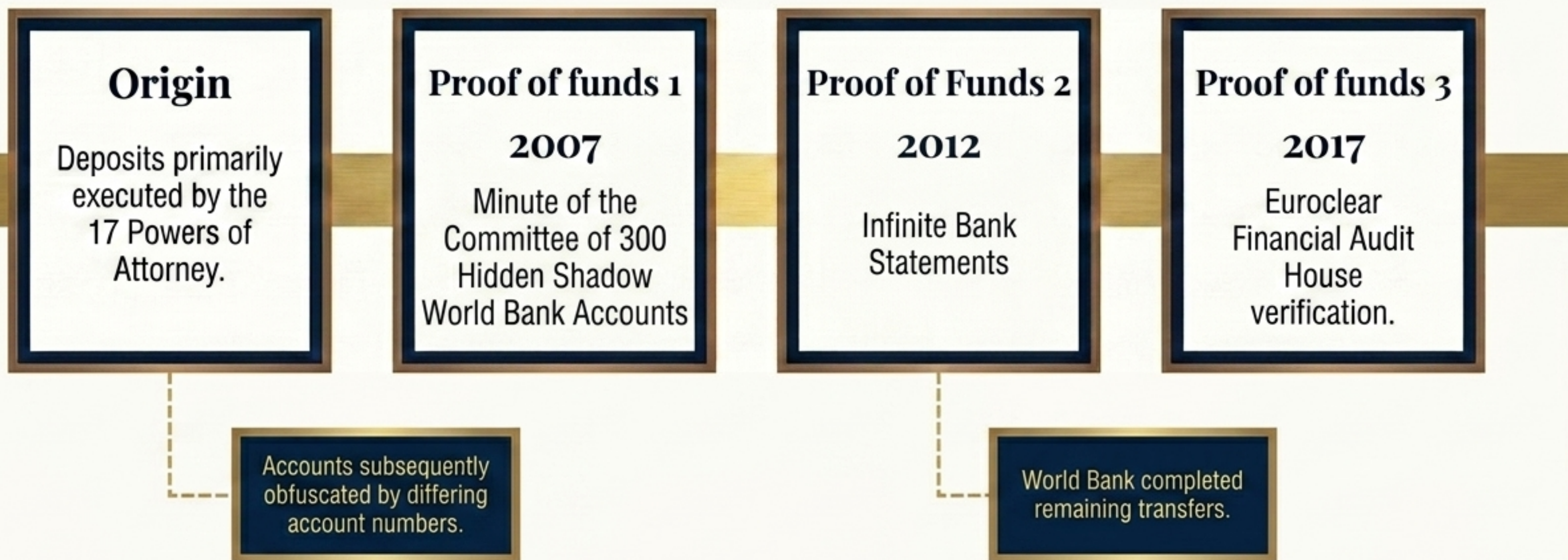

The Legal Rule

A corporation, government, or individual, once bankrupt, is legally deemed incompetent. Any further contracts entered into are rendered null and void.

The Diagnosis

Diagnosis 1

Payments on national debts far exceed payments supporting public goods, proving government incompetence.

Diagnosis 2

Debt, and the absence of reference to credit, proves gross mismanagement of the trusts.

Diagnosis 3

The Minute of the Committee of 300 explicitly prohibits 'programming' of funds.

Therefore, all fiat currencies, corporate entities, and digital currencies (including the Quantum Financing Service) are unbacked and legally bankrupt.

The Rothschild Precedent.

Reference Item 61-27 of the Minute (Writ 111) — establishing the bankruptcy of related banking families.

The Complicity Hierarchy

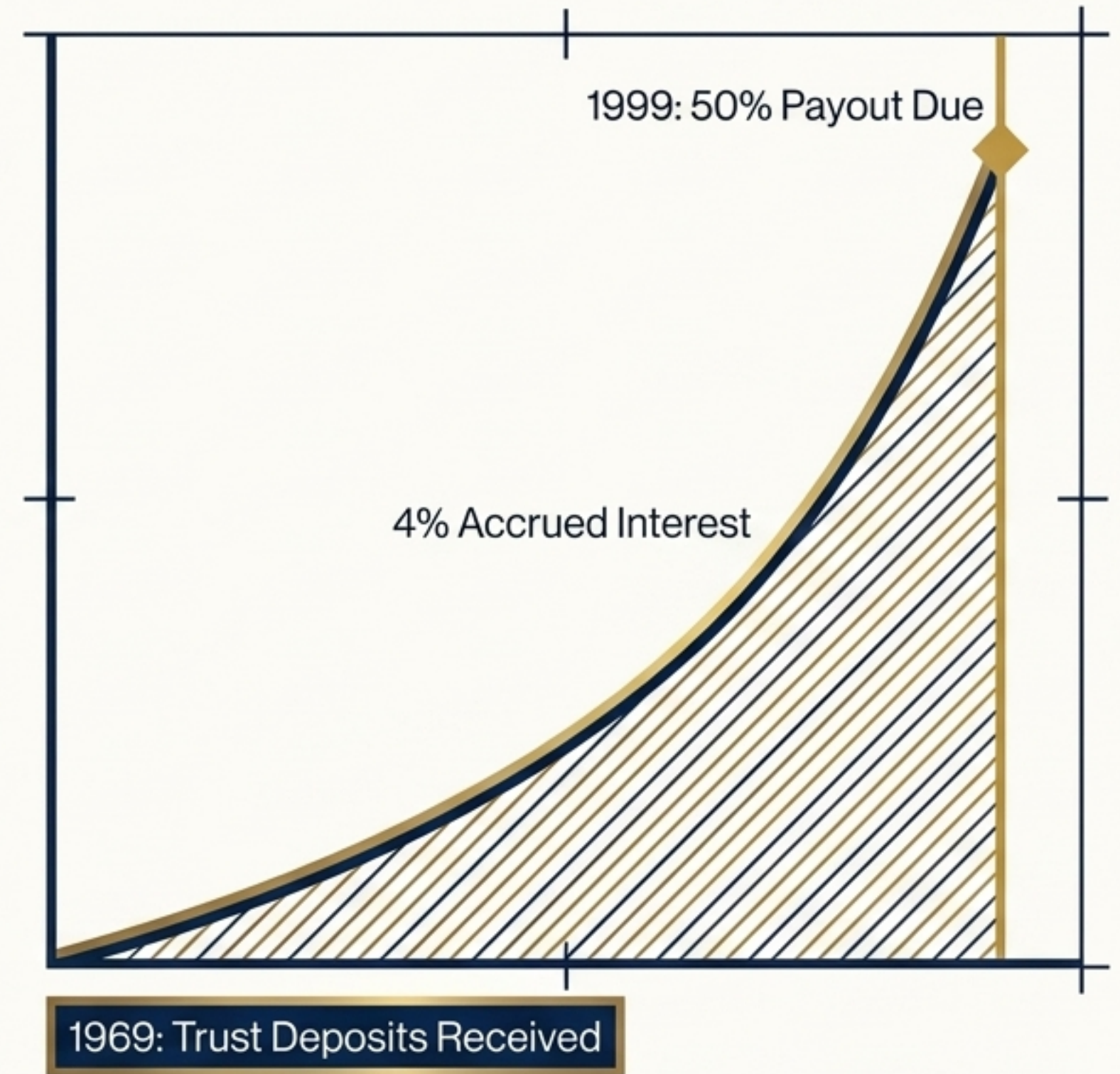


Overview of the Co-Trustee Mandate



MANDATE 01: STUDY THE RECORD

Study the Minute of the Committee of 300, Which confirm trust deposits received in all countries, in 1969. to accrue 4% interest for 30 years, when 50% was to be paid out, in 1999.



MANDATE 02: DISSEMINATE & EDUCATE

Disseminate the information to educate & design a ‘do no harm’ economy.

Current Bankrupt System	Alpha Omega System (‘Do No Harm’)
Corporate theft from citizens; Systemic birth certificate fraud.	Functions strictly under the laws of the land.
War, climate, health, and governance weaponized as economic strategies.	Humanity established as explicit beneficiaries; Do No Harm parameters.
Usury and debt-based.	Usury and debt-free; Pre-established templates and platforms ready for deployment.

MANDATE 03: SERVE NOTICE OF CLAIM

Serve ‘Notice of Claim’ to the banks holding trust accounts.



MANDATE 04: ASSERT BANKRUPTCY

Call to action: remind the signatories.

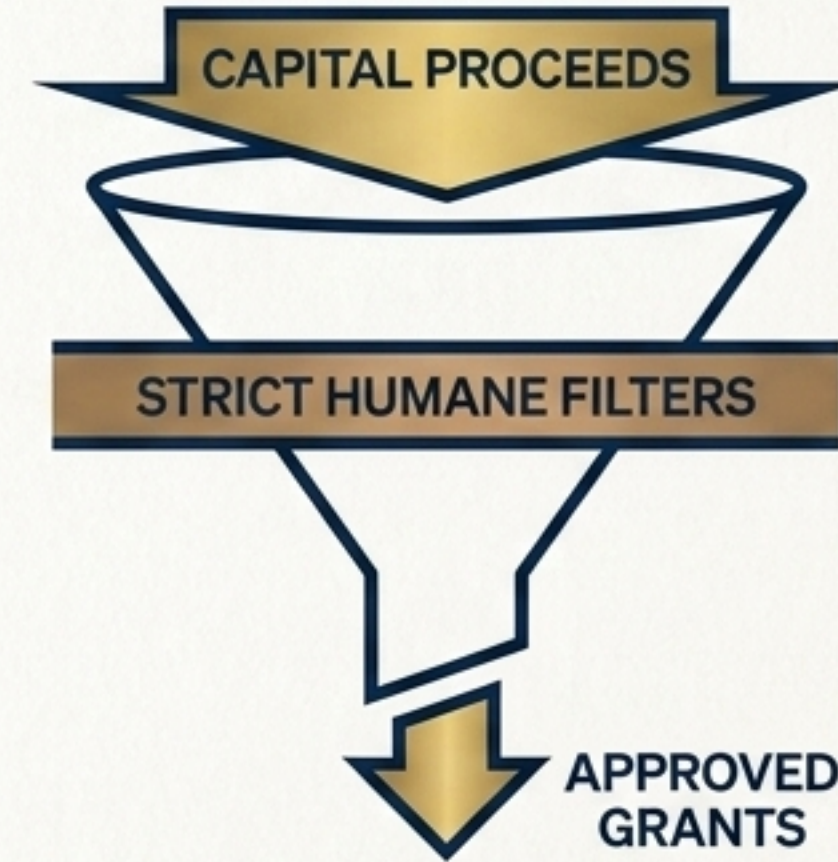
